Trial 1 and 2 - 100 runs online (61%), 65 runs paper (39%); each day. If either form of entry has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either one accordingly.

Paper entries received within the first 24 hours must include postage or be metered. Entries must be delivered by multi-state or multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS, and DHL. You must waive the signature requirement for delivery services, if applicable.

Limit of 10 dogs per envelope. No hand deliveries can be accepted in the first 24 hours.

No FAX or email entries will be accepted for this trial.

All entries must be submitted on official AKC Agility entry forms, one dog per entry form.

Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

If you would like confirmation that your entry was received before the trial has closed, please include your email address or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed. **Please check your entries!**

“After Closing” Waiting List

A waiting list (30 run maximum each trial) will be maintained for these trials once they have closed on April 5. The waiting list will be active until its deadline — Wednesday, April 20, 6:00 pm CST. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. **If a run is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the run.** Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

Class Description

Please see the AKC Regulations for Agility Trials for current class descriptions. **Dogs must be entered only in Regular Classes or Preferred Classes with no crossover between them allowed at the same set of trials.**

Obstacles

Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials. Contacts are rubberized.

Dogs Eligible to Enter

This trial is open to PBGVs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Tentative Running Order/Start Times

Trials 1 and 2 will be run concurrently as shown below.

All dogs competing in agility must **possess** an official AKC Jump Height Card. **You are not required to show your height card or send a copy with your entry. Move-ups

For the Tuesday April 26 Trials 1 and 2 : MOVE-UPS close at 6:00 pm CST, Wed, April 20. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

Trial Information

Set up time will be announced in the confirmation information.

Trial hours are 7:00 am to 30 minutes after completion of the trial.

Ring size: 80' x 100'.

The building is climate-controlled. There is plenty of close parking and crate space. Please bring chairs, crates and water for your dogs, and clean up supplies. Dogs may not be left in the building overnight.

No laser pointers may be used inside the agility room or its hallway to the middle room.

Due to the tight space in the agility room, only dogs running in the current class/grouping are permitted in this area. Dogs should be returned to the crating area after their runs. Please do not block the paths to the entrance/exit of the ring.

Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

The Petit Basset Griffon Vendéen Club of America (PBGVCA) may cancel this event in extreme weather conditions.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Bitches in season - PBGVCA will retain \$10 (for expenses) from the first entry of a dog entered in obedience, rally or agility that is withdrawn due to being in season. If the bitch is on-site, verification must be made by the Show Chairman or Charman's designee. A veterinarian letter, on the practice's letterhead, will be accepted if submitted within the time frame designated in the AKC policy noted below.

AKC Refund Policy - Withdrawals after the event's closing date and time due to a change of judge must receive a full refund (no fee is paid to the AKC). Females in season must be fully refunded if withdrawn after closing and no later than one half hour prior to start of the first class of the day of the trial. The club may retain a processing fee as specified in the premium list.

The clubs will refund all but \$10.00 of the entry fee per day for injured dogs or handlers. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's or doctor's letter must be provided within one week of the trial. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

NO flexi leads are allowed.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. PBGVCA has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement. Junior Handlers must enter their JH# and complete back of form.

Include only AKC titles on entries.

Owners are responsible for errors when making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

PBGVCA does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

No refunds will be issued for overpayment of less than \$12.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.

PBGVCA, their Board and Members, and Dog Sports at Kim's and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event. No professional photography or videotaping is permitted without permission.

COVID-19 Guidelines for this trial

All participants will need to sign the COVID waiver for admittance. Waivers will be emailed to all entrants, and available online and at the show. The PBGVCA National Committee will continue to review the local guidelines and will update the requirements as needed. See pbgv.org for more information.

The mask policy for this trial will comply with the current CDC guidelines, which at the time of this notice state that all exhibitors will be required to wear a mask at all times in the building. If the CDC recommendations change between the time of this notice and the trial, we will update our policy as necessary to comply with them.

Entry and Exit to the agility ring will be by swing gates, covered with a disinfectant-soaked towel.

A leash runner will be provided. They will use a mechanical "grabber" to transfer leashes. The "grabber" will be dunked in disinfectant between uses. Exhibitors may choose to carry their leas on their person during thei run per AKC rules.

There will be a 6' boundary set around the Gate Steward, Trial Secretary, Judge's Table and the Timer and Scribe table. Please respect these boundaries. ONLY the Gate Steward will be allowed to check dogs in, move dogs, etc.

Printed copies of the course maps will be posted in several locations. Course maps will also be posted at www.dogwoodeventservices.com the morning of each trial. The running order, Judges briefing (if made available to the trial secretary), Trial Chair briefing (if made available to the trial secretary), and results will also be posted at www.dogwoodeventservices.com.

PLEASE REMEMBER TO WASH YOUR HANDS FREQUENTLY AND PLEASE PRACTICE PHYSICAL DISTANCING.

Workers

Volunteers will be needed for the smooth running of this trial. Volunteer workers will be gratefully acknowledged with lunch. A sign-up link will be provided after closing.

Prizes and Awards

Rosettes will be awarded in each jump height division in each class as follows. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

1st place	Blue
2nd place	Red
3rd place.....	Yellow
4th place.....	White
Qualifying	Green

MACH/PACH rosette and decorated MACH/PACH bar will be awarded.

Placements and High in Trial at the Regional Trial will also receive a dog related item.

Placements and High in Trial at the National Trial will also receive a dog metal item.

The PBGVCA National Agility Challenge Trophy will be awarded to the winner of High in Trial at the National Agility Trial. Highest Scoring Dog in Trial is awarded on the basis of the highest score which must be 100. If there is a tie for the highest score, then the dog with the most yards per second prevails. Standard run time will be adjusted for the pause table when figuring YPS for High in Trial only.

The National Agility Challenge Trophy is offered by Megan & David Esherick. The Memorial Trophy is a silver bowl on a wooden base in memory of MACH 6 PACH Clancy's Capsaicin Rush VCD2 RAE MXC3 PAD MJG3 MXP3 MXPB MJP4 MJPB PAX OF T2B RHX CGCA TKP.

The current memento is a walnut plaque onto which their 8x10 win photo can be mounted. For permanent possession the trophy must be won three times by the same owner, not necessarily with the same dog or at consecutive trials.

PLEASE NOTE: Only PBGVCA members in good standing at the time of the Specialty are eligible to be awarded Club Trophies. For Agility High in Trial Trophy PBGVs with a PAL or ILP number must submit DNA showing the dog is a purebred PBGV.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle and then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

Entering for Exhibition Only (FEO) - Offered for FAST and T2B

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (eg, when checking in at the gate board).
- Toys are allowed in the ring. Toys must be non-audible and may not leave the handler's hand. Toys that roll freely may not be used.
- Food/treats are not allowed in the ring.
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and/or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
